The intended audience for this conference is podiatrists who have completed residency and are in practice; Podiatrists currently in residency; Podiatric medical school students; College students interested in the field of podiatry. There are no pre-requisites for attending this conference.

Objectives:

- Identify strategies for fostering innovation in foot and ankle surgery while maintaining patient safety and ethical standards.
- Describe pathways for translating surgical ideas into clinically viable techniques, devices, or practice improvements.
- Review the mechanisms, indications, and perioperative considerations of GLP-1 inhibitors relevant to foot and ankle surgical patients.
- Evaluate potential impacts of GLP-1 therapy on surgical risk, wound healing, and postoperative outcomes.
- Describe indications, surgical techniques, and fixation options for deltoid ligament repair.
- Assess postoperative protocols and potential complications associated with deltoid repair procedures.
- Review current orthobiologic options used in foot and ankle surgery and their proposed mechanisms of action.
- Evaluate evidence-based indications and limitations for orthobiologic use in surgical and non-surgical treatment.

- Analyze complex or controversial foot and ankle cases with attention to differing surgical decision-making approaches.
- Compare outcomes associated with alternative treatment strategies in challenging clinical scenarios.
- Identify indications, surgical approaches, and fixation techniques for tarsometatarsal joint fusion.
- Recognize common complications and strategies to optimize fusion rates and patient outcomes.
- Discuss current minimally invasive surgical techniques in foot and ankle surgery and appropriate patient selection.
- Compare benefits, limitations, and complication profiles of MIS versus open procedures.
- Identify common intraoperative and postoperative complications in foot and ankle surgery.
- Develop systematic approaches to managing and mitigating complications when they occur.
- Recognize clinical signs and diagnostic methods for peripheral arterial disease in foot and ankle patients.
- Integrate PAD management principles into surgical planning and limb preservation strategies.
- Evaluate real-world surgical complications to identify contributing factors and decision points.
- Apply lessons learned from case review to improve future surgical outcomes.
- Describe principles and indications for gradual deformity correction using external fixation or other methods.
- Compare gradual correction techniques with acute correction in terms of outcomes and complication risks.
- Examine challenges and ethical considerations in delivering foot and ankle surgical care in global health settings.
- Identify sustainable strategies for improving surgical access and outcomes in resource-limited environments.
- Identify common complications associated with total ankle arthroplasty and strategies for prevention.
- Discuss evidence-based approaches to managing TAR complications through case-based panel discussion.
- Review joint-preserving surgical options for management of 1st metatarsophalangeal joint pathology.
- Compare indications, outcomes, and limitations of various 1st MPJ salvage techniques.
- Describe current and emerging applications of artificial intelligence in foot and ankle surgery.
- Evaluate potential benefits, limitations, and ethical considerations of AI integration into clinical practice.
- Identify common medicolegal risks in foot and ankle surgical practice.
- Develop strategies for risk mitigation, documentation, and malpractice management.
- Review current evidence regarding early weight-bearing protocols following bunion, TAR, and trauma surgery.
- Discuss patient selection and risk factors when implementing early weight-bearing strategies.
- Describe the design rationale and surgical technique for use of custom 3D-printed midfoot cages.
- Evaluate early clinical outcomes and potential complications associated with this reconstructive approach.
- Identify indications and failure modes leading to total ankle arthroplasty revision.
- Discuss surgical planning considerations and case-based decision-making in TAR revision surgery.
- Describe surgical anatomy and technique associated with a posterior approach to supramalleolar osteotomy.
- Assess potential advantages, limitations, and complications compared with traditional approaches.

- Identify indications for arthroscopic-assisted tibiototalcalcaneal fusion following failed ankle ORIF.
- Describe technical considerations and postoperative outcomes associated with this minimally invasive approach.
- Identify risk factors for intraoperative medial malleolar fracture during total ankle arthroplasty.
- Evaluate fixation strategies and decision-making related to prophylactic pinning.

Speakers:

- **Gregory C. Berlet, MD, FRCS(C)** is an orthopedic surgeon specializing in foot and ankle surgery and sports medicine. He retired as a partner at The Orthopedic Foot and Ankle Center (OFAC) in Columbus, Ohio, in August 2025. Dr. Berlet is the former Chief of the Division of Foot and Ankle Surgery at The Ohio State University College of Medicine and Public Health and served as a consulting physician for the Columbus Blue Jackets NHL franchise for 27 years. He has been recognized as a Top Doc in Orthopedics for 11 consecutive years. A nationally recognized leader in orthopedic education, Dr. Berlet is a past Chairman of the Education Committee for the American Orthopaedic Foot & Ankle Society (AOFAS) and a past board member of the AAOS Council on Education. He is an orthopedic innovator who has led and participated in implant design teams focused on foot and ankle surgery. He has authored more than 150 scientific publications and is the founding editor of *Foot & Ankle Specialist*, Foot and Ankle Editor for *Orthopedics Today* (Healio.com), and a partner in Foot Innovate. Dr. Berlet completed fellowship training in both foot and ankle surgery and sports medicine. He earned his Bachelor of Science degree from the University of Western Ontario and his medical degree from the University of Calgary. He completed a foot and ankle surgery fellowship at Carolinas Medical Center in Charlotte, North Carolina, and a sports medicine and arthroscopy fellowship at the University of Toronto. He is board certified by the American Board of Orthopaedic Surgery and the Royal College of Surgeons of Canada and is an emeritus member of the COA, AOA, AAOS, and AOFAS.
- **John Evans, DPM, DABFAS, FACFAS:** Dr. Evans received his DPM from the Temple University College of Podiatric Medicine and has a BS in Pharmacy from the University of Connecticut. He is board-certified by the American Board of Foot and Ankle Surgery (Foot and Ankle) and is Chief of Podiatry at Corewell Health (Beaumont) Medical Center in Dearborn, Michigan. He has served as Chair of the American Podiatric Medical Association (APMA) Health Policy and Practice Committee and as a Medicare Carrier Advisory Committee (CAC) representative for over 20 years and was the 2018 recipient of the APMA Award of Excellence. He was the Podiatric representative to the 2024 PAD Guidelines Writing Committee of the American Heart Assn. and American College of Cardiology and serves as the Podiatric representative of APMA to the AHA PVD Leadership Council. He is active with the American Board of Foot and Ankle Surgery, having served on multiple committees including their Board of Directors for eight years, and is a Past-Chair of their Communications Committee. He is active with the American Limb Preservation Society on the Health Equity and Advocacy Committee as Co-Chair of the Research and Data Analysis Sub-Committee, the CLI Global Society, and as faculty for the New Cardiovascular Horizons organization, AMP, Desert Foot, SAWC, PRESENT, Highlands Institute, and the Goldfarb Foundation. Dr. Evans is a nationally recognized speaker on a variety of topics including Peripheral Arterial Disease, the Diabetic Foot, Limb Salvage and Preservation, Physician Burnout, Dealing with the Difficult Patient, and Mindfulness in Medicine, and is a consultant to multiple vascular and legal organizations. He resides in Michigan.
- **Steven Cooperman:** Steven Cooperman is a fellowship-trained foot and ankle surgeon. He completed his residency with Highlands/PSL in Denver, and his fellowship at the Orthopedic Foot

and Ankle Center in Columbus, Ohio. He now practices in Castle Rock, CO at Rock Canyon Foot and Ankle Center.

- **Lauren Adler:** Dr. Laura Adler grew up in Miami, Florida, in a family with deep ties to the medical field. After earning her bachelor's degree from Florida State University, she graduated at the top of her class from Temple University School of Podiatric Medicine. Dr. Adler completed her 3-year surgical residency at Presbyterian St. Luke's in 2022, followed by a one-year reconstructive fellowship in Boca Raton, Florida. Since completing her fellowship, she has joined her father's private practice, Adler Foot and Ankle in North Miami Beach. In addition to her clinical work, Dr. Adler serves as an adjunct professor at Barry University Podiatry School and mentors residents in two local residency programs.
- **RICHARD DENER:** Richard Dener, DPM, FACFAS is a past President of the American College of Foot and Ankle Surgeons and previously served as Program Director at Inova Fairfax Medical Campus. He is recognized for his leadership in foot and ankle surgery education and his long-standing contributions to residency training and professional development within the field.
- **BRAIN DERNER:** Dr. Brian Dener graduated from the Highlands/PSL residency in 2021 and completed the CORE Institute Foot and Ankle Fellowship in 2022. He currently practices in the Northern California Bay Area at Kaiser Permanente's Department of Orthopedics in San Leandro and serves as faculty for the Kaiser South Bay Podiatric Residency Program. Additionally, he is a lecturer for AO North America, Cofounder of the medical mission nonprofit Bones Pro Bono and a case reviewer for ABFAS.
- **REBECCA STACK:** Dr. Rebecca Stack completed her Highlands-PSL residency in 2020. She went on to achieve board certification through the American Board of Foot and Ankle Surgery in both Foot Surgery and Reconstructive Rearfoot/Ankle (RRA) Surgery—all while welcoming three children. She has been in private practice in the Chicago suburbs for over five years (although she definitely misses Colorado) and currently serves as the Assistant Director for the Northwest Illinois Foot and Ankle Fellowship. Outside of medicine, she is married and the proud mother of a 4-year-old son, a 2-year-old daughter, and a 5-month-old daughter.
- **JORDAN CAMERON:** Dr. Jordan Cameron, DPM, is a board-certified foot and ankle surgeon in Colorado Springs, Colorado, affiliated with the Foot and Ankle Institute of Colorado. He received his DPM from Barry University and completed his surgical residency at Florida Hospital East Orlando.
- **JAKE MCLEOD:** Dr. Macleod is a highly skilled Foot & Ankle Surgeon at Longview Orthopedic Associates in Longview, Washington, and an Attending Faculty member for the Reconstructive Foot & Ankle Surgery Fellowship at Washington Orthopaedic Center Advanced. - **SCOTT CARRINGTON:** Dr. Carrington is an attending physician at Gundersen Health in La Crosse, WI. He earned his degree from Des Moines University and underwent residency training at the Highlands/PSL program in Denver, CO. Following this, he pursued a fellowship in advanced foot and ankle reconstruction at Coordinated Health in Bethlehem, PA. Dr. Carrington is dedicated to research and resident education, serving as a surgical skills committee member for the American College of Foot & Ankle Surgeons. - **TIM MINEO:** Dr. Timothy Mineo a distinguished Foot and Ankle Surgeon originally from Texas. Dr. Mineo completed his undergraduate education at the University of Colorado Boulder, where he was a student-athlete. After some time in Lake Tahoe working as a ski bum and boot fitter, he went on to pursue his medical studies at Rosalind Franklin University. Dr. Mineo completed his residency at Legacy/Kaiser in Portland, Oregon, where he honed his skills in trauma and deformity correction. He then joined Advantage Orthopedic before founding Pearl Foot and Ankle, where he now specializes in sports medicine, arthroscopy, complex revisional surgery, and total ankle replacement. Dr. Mineo is certified by the American Board of Foot and Ankle Surgery (ABFAS).
- **ALAN NG: Alan Ng, DPM, FACFAS** is a foot and ankle surgeon with Orthopedic Centers of Colorado. He currently serves as President of the American College of Foot and Ankle Surgeons (ACFAS) and is the Fellowship Director of the Rocky Mountain Reconstructive Foot and Ankle Fellowship. Dr. Ng is a Past President of the American Board of Foot and Ankle Surgery (ABFAS) and President of the Greater Texas Education Foundation, the overseeing body for Houston-area residency programs.
- **MICHAEL GENTILE: Michael A. Gentile, DPM, D.ABFAS, FACFAS** is a foot and ankle surgeon with a comprehensive practice spanning the full spectrum of surgical care. He completed his DPM at the California College of Podiatric Medicine and a reconstructive foot and ankle surgical residency at HealthOne/Presbyterian St. Luke's in Denver. Dr. Gentile's clinical interests include trauma, deformity correction, sports medicine, non-union, osteomyelitis, and clinical research. He serves as San Francisco Site Director for the Kaiser Bay Area Foot and Ankle Residency, Chair of the ACFAS Surgical Skills Committee, AO North America faculty, and is a reviewer and former trauma section editor for the *Journal of Foot and Ankle Surgery*.
